## Ntawv: Minnesota Kev Kawm Ntawv Txiaj Ntsim thiab Kev Rho


Back to School Tax Reminder: Minnesota Education Credit and Subtraction

## **Khaws Cia Koj Cov Ntawv Povthawj Yuav Khoom Siv rau Kawm Ntawv rau Koj Qhov Se Tau Rov Los ntawm lub Xeeb!**

Thaum koj ua koj cov Minnesota se, tej zaum koj yuav siv tau koj tus menuam cov nqi kawm ntawm los **ntxiv** lossis **rho** tawm los ua se. Ntawm no hais txog cov menuam kawm qib kindergarten mus txog high school.

Yog koj yuav qhov nyiaj rho tawm los ntawm qho se koj tiv (credit) uas qhov se koj tiv qi dua. Yog qhov nyiaj rho tawm los ntawm qho se koj tiv (credit) ntau dua koj cov se, tej zaum koj yuav tau nyiaj rov qab. Tiam sis yog koj khwv tau nyiaj ntau, koj ua tsis tau qhov nyiaj rho tawm los ntawm qho se koj tiv (credit). Yog li ntawm, tej zaum koj siv tau qhov rho tawm.

Qhov rho tawm ua rau koj qhov nyiaj khvw tau los qi dua ces koj tiv se tsawg dua. Tiam sis koj tsis tau nyiaj rov qab los yog muab rho tawm.



Rau ntawm tej zaus tsawg, koj kuj siv tau nyiaj rho tawm los ntawm qho se koj tiv (credit) **thiab** qhov rho tawm. Nrog koj tus neeg ua se tham yog koj muaj ib tug menyuam nyob high school thiab koj them kawm ntawv qib siab lossis nyiaj rau ib lub tsev kawm ntawvm ntiav.

Lub Txiaj Ntsim

Koj lub txiaj ntsim pub txog 75 feem pua ntawm cov nuj nqis tau them rau koj tus menuam kawm qib K-12, kom tau siab li siab tau. Siv tsis tau qhov seem 25 feem pua los rho koj nqi se. Qhov nyiaj muab rov qab tau ntau tshaj plaws yog sib npaug rau \$1,500 rau ib tug menuam rau ib tsev neeg twg tiamsis muaj feem txo tau yog koj cov nyiaj khwv tau los ua ntej txiat se yog ntau tshaj \$70,000.

Piv txwv, yog koj muaj 1 lossis 2 tug menuam tsim nyog, koj muaj feem thov tagnrho lossis ib qho ntawm koj cov nyiaj rov qab yog koj cov nyiaj khwv tau los ua ntej txiav se yog \$76,000 lossis tsawg dua. Yog koj muaj menuam coob dua 2 tug, qhov nyiaj ciaj ciam mus txog \$3,000 rau ib tug menuam.

**Sau cia:** Rau xyoo ua se 2022 thiab ua ntej, koj yuav tau siv cov nyiaj tsev cov neeg khvw tau los es tsis txhob siv cov nyiaj ua ntej txiav se los mus xyuas seb koj puas muaj feem tau qhov nyiaj rov qab.

Yog koj yeej muaj txij nkawm thiab nyias ua nyias ntawv se, ces koj TSIS tau tus txiaj ntsim.

### **Kev Rho Nqi Se**

Tej nyiaj khvw tau tsis cuam tshuam rau rho nqi ua se. Nrho tawm mus txog \$1,625 rau ib tug menuam kawm ntawv qib K-6 thiab \$2,500 rau tus menuam uas kawm qib 7-12.

Rau cov menuam kawm ntawv qib 6 thiab 7, siv lub xyoo xaus rau tus menuam qib los ua se. Rau cov menuam pib kawm ntawv qib siab rau lub xyoo ua se, siv nqi ntawm xyoo nws kawm qib 12. Tbasis koj tsuas rho tau cov nqi muaj feem thaum tseem kawm qib 12 xwb.

Ntxiv ntawd, yog koj ua qhov rho tawm, koj tus menuam yuav tsum mus kawm ntawv hauv Minnesota, Wisconsin, Iowa, North Dakota, lossis South Dakota.

### **Kuv toobkas dabtsi thiaj txais tau tus txiaj ntsim lossis qhov yuav rho nqi?**

Yuav kom txais tau tus txiaj ntsim lossis qhov rho nqi se ces yuav tsum khaws tej ntawv pov thawj them nuj nqis thaum koj yuav khoom rau menuam kev kawm ntawv, xws li tej cwj mem qhuav, mem kob, cov mem kob zas, cov phau ntawv sau, tej cav taus lej thiab lwm yam.

Koj kuj muaj feem txais tej txiaj ntsim rau tej yam xws li no:

- Tus nqi computer thiab txuj ci tshiab kawm ntawv (mus txog \$200)
- Ntiav neeg qhia ntawv
- Cov phau ntawv siv rau kev kawm
- Nqi them rau lwm tus coj menuam mus kawm ntawv
- Kev kawm suab paj ntsha txuj
- Cov khooskas qhia ntawv tom qab lawb ntawv
- Cov kev kawm lub caij so



Ib co nqi sau tau qhov rho tawm tiam sis tsis tau nyiaj rho tawm los ntawm qho se koj tiv (credit). Piv txwv, koj siv tau cov nqi them kawm ntawv ntiav lossis kawm ntawv qib siab (thaum koj tus menuam nyob High School) rau qhov rho tawm.

### **Cov Ntawv**

**Kom tau tus txiaj ntsim**, siv daim ntawv Schedule M1ED nrog koj daim Se Minnesota State Tax Form.

**Kom tau tus nqi rho tawm tus nqi se thaum koj tsev neeg dhau qhov txiaj tsim teem kawg lawm**, siv daim ntawv nyob hauv Schedule M1ED lus qhia ua.

**Nco ntsoov** koj YUAV TSUM khaws koj cov ntawv pov thawj thaum yuav koom thiaj txais tau cov txiaj ntsim thiab rho nqi se.


