Waa maxay hay'ada baaritada kireystahu?

Qaar badan oo qolyaha guryaha ahi waxa ay isticmaalaan hay'ad u soo baara kiraystayaasha. Hay'adaha baaritaanadu waxa ay helaan akhbaar ku saabsan kireystayaasha waxayna ka gadaan qolayaha guryaha leh. Waxay soo eegaan waxyabaha sida:

- Hadii dacwo guri ka saarid hore ah aad lahayd
- Ciwaankaaga 3 dii sanno oo la soo dhaafay
- Wuxuu qolyihii guryihii hore ay kaa sheegaan
- Kiridhidkaaga si ay u eegaan in lacag lagu leeyahay
- Inaad dambi hore u gashay iyo in kale

Ma sii soo noqon khidmada codsigaygu?

Qolada guryahu badanaa waxa ay qaadaan khidmad codsi. Hadii qolada gurigaagu ay kaa qaadeen khidmad codsi waa inay kuu sheegaan shuruudaha ay adeegsadaan si ay u go'aansadaan inay guri kaa kireeyaan iyo in kale. Shuruudaha waa liis ah waxyabaha ay eegaan sida kiridhidka, taariikhda guri kireysiga, iwm.

Hadii codsigaaga la diido, inta badan lama soo celiyo khidmada codsiga. Laakiin qolada gurigu waa inay kuu soo celiso khidmada codsiga adiga hadii:

- Hadii aysan u isticmaalin inay ku bixiyaan warbixinta baarida, warbixinta kiridhidyaada ama ay ku bixiyaan waydiinaha dadka horey kuu yaqaanay
- In gurigii la siiyey qof hortaa codsaday
- Ay diideen codsigaaga iyagoo ku salaynaya shuruud aan laguu sheegin kolkii aad guriga codsanaysay.

Muddo intee le'eg ayey warbixinta baarida kiraystahu dib u eegi xaaladayda?

Hay'adaha baarida kireystahu kaliya waxa ay soo sheegaan biilalka aan la bixin iyo guri ka saaritaanada ilaa 7-sanno Musalifaayada waxaa la soo sheegaa ilaa 10 years. Dambiyada horey loo galay waxaa la soo sheegi karaa intii la rabo, laakiin xirida ama wixii kale ee bilayska la xiriira waxaa la soo sheegi karaa uun 7-sanno.

Guri ka saaritaanada [marmarka qaarkoodna loogu yeero haysasho sharci-darro ah ama (Uds)] waxay soo sheegaan ilaa 7-sanno hay'adaha baaridu. Kiiska guri ka saarida ahi waa wax diiwaanka dadweynaha gala. Wuxuu soo baxaa xataa haddii aad ku guulaysato ama aad waanwaan lagu dhameeyo kiiska, aad guurto, ama aad bixiso dhamaan kiradda lagugu leeyahay. Marmarka qaarkood, waa aad kala xaajoon kartaa maxkamadda in la qariyo kiiska haddii mulkiilaha gurigu uu ogolaado taa.

Ogow: Guri ka saaridu waa ay uu ku jiri karaa **diiwaanada maxkamada** muddo aad uga dheer 7-sanno.

Hadii maxkamadu ay kaa tirtirto kiiska guri ka saarid ah, kolkaa hay'adaha soo baarida kireystahu ma soo sheegi karaan. Kolkaa kiis la tirtiro Maxkamada waxa masaxdaa diiwaanada maxkamada.

Laga bilaabo bisha Janaayo 1, 2024: sharci cusub oo gobolku leeyahay aaya waxa uu yiraa waa in dhamaan diiwaanadda guri ka saaritaanadda oo dhami ay iskood u tirtirmaan 3 sanno ka dib kolka ay maxkamaddi amato guri ka saarida.

Wax kale ma ka sameyn karaa guri ka saarida diiwaankayga ku jirta?

Waxaa aad gelin kartaa oraah warbixintaada baarida taa sharxaysa guri ka saarida. Tusaale ahaan, waxa aad sharxi kartaa inaad shaqo la'aan noqotay aadana awoodin inaad kirada bixiso, laakiin aad shaqeynaysay ilaa waqtigaa wixii ka dambeeyey. Ama waxa aad sharxi kartaa in dhibka qof kale uu keenay, laakiin qofkaasi iminka uusan kula noolayn. **Sheeg waxa noloshaada iska bedelay si kolkaa wax kasta oo keenay in adiga guri lagaa saaro aysan u dhicin hadda.**

Hay'ada soo baaridu waa khasab inay ku daraan oraahdaada wixii warbixin cusub ah ee adiga kugu saabsan ee ay dirto. Wuxaa kalood ka codsan kartaa hay'ada baaridu in ay u dirto oraahda cidii qolo guri ah ee heshay warbixin adiga kugu saabsan 6 dii bilood ee la soo dhaafay.

Sidee ayaan ku arki karaa warbixintayda baarida kiraystaha ah?

Qolada gurigu waa khasab inay kuu sheegto magaca, ciwaanka iyo lambarka telefanka hay'ada baarida kolka aad codsato guri. Qolada gurigu waa ku tusi kartaa warbixinta hadii aad rabto. Hay'ada kuma khasbi karto qolada guriga inay warbixinta ka dhigaan xog xafidan.

Hadii qolada gurigu ay kaa siin waydo nuqul, kolkaa ka hel nuqul hay'ada baarida kiraystaha. Waxaa dhici karta inaad ka hesho warbixintaada markiiba khadka (online) ka. Eeg shabakadaha (websites) hay'ada ee ku qoran gadaalka warqadan xogta aruursan ah. Ama buuxi foomkan ku lifaaqan ka dibna u dir hay'ada. Sidoo kale u dir nuqul ah labada dhinac horey iyo gadaal ee Aqoonsigaaga (ID) gobolka ama Degmada ama laysinka darawalka). Nuqul kala har foomka ka

dibna ku qor taariikhda aad dirtay. Hay'adu waa khasab inay boostada kuugu soo dirto warbixinta 5-cisho gudahood kolka ay hesho foomkaaga.

Waa intee kharashka warbixintu?

Warbixintu waa lacag la'aan hadii:

- Hadii guri laguu diiday, ama kiradaadu ama dabaajigaagu uu kordhay 30-cisho ee la soo dhaafay iyadoo sababtu tahay warbixinta ama
- Aadan shaqeyn laakiin aad dalban doonto shaqo 60-cisho ee soo socda ama
- Aad hesho gargaar dowladeed, sida SSI, RSDI, MFIP, GA, Gargaar Cunto, ama
- Aad aaminsan tahay in warbixinta ay ugu jiraan wax khalad ah musuqmaasuq awgii

Hadii kale, waxaa jiri kara khidmad yar oo la bixiyo. Taasi waxay hadba ku xiran tahay hay'ada.

Ma arki karaa warbixintayda ka hor inta aanan guri codsan?

Shirkadaha soo baarida intooda badani ma sii hayaan galalka kireystayaasha. Hadii shirkadi aysan waligaa adiga warbixin kaa diyaarin, ma hayn doonaan mid ay ku tusaan. Ha waydiisan warbixin ilaa iyo inta guri laguu diidayo iyadoo sababtu tahay warbixin.

Hay'adu maxay ii soo diri aniga?

Ka dib kolka ay hay'ado hesho warqadaada iyo aqoonsigaaga (ID) sawirka leh, waxa ay haystaa 5-cisho oo ay kuugu soo diri:

1. Dhamaan akhbaarta galkaaga ku jirta waqtiga codsigaaga (tani badanaa waa warbixinta baarida kireystaha)
2. Meesha ay ka heleen akhbaarta (magaca, lambarka telefanka, iyo ciwaanka ee cid walba oo siisay xog aniga igu saabsan)
3. Magacyada dhamaan qolyaha guryaha ee ka helay nuql warbixintaada sannadkii la soo dhaafay **iyo**
4. Oraah ka hadlaysa xaquuqdaada dhanka sharciga.



Ka waran hadii aan ka helo khaladaad warbixinta?

Waxa aad xaq u leedahay inaad saxdo wixii khalad ah.

- U qor warqad hay'ada baarida oranaysa xogta khaladka ahi waxa ay tahay. Faahfaahin inaa ka bixisaa mar walba waa ay fiican tahay taa. Tusaale ahaan, hadii guri ka saarid warxbixinta ku qoran aadan adigu lahayn, u sheeg meesha aad ku noolayd kolkii dacwada guri ka saarida ah la xareystay. Warqadaada nuql kala har adigu.
- Hay'adu waa inay eegtaa xog walba ee aad tiri waa khalad. Sameynta taa awgeed lacag kaagama qadai karaan. Waa khasab inay saxaan warbixintaada ayna uga saaraan xogaha aysan cadeyn karin 30-cisho gudahood kolka ay helaan warqadaada.

- Hay'adu waa ay diidi kartaa inay eegto waxa hadii aadan siin akhbaar ku filan. Hay'adu waa inay kuu sheegtaa hadii ay diido inay kuu eegto waxa aad codsatay in la eego. Hadii ay taasi dhacdo, u dir warqad kale oo siinaysa iyaga faahfaahino badan oo kale.
- Kolka hay'adu ay dhamayso eegitaanada, waa inay kaa siiyaan nuqlu warbixintaada cusub ama ay kuu sheegaan inaysan helin wax khalad ah.
- Waa aad ka heli kartaa in hay'ada baarida kireystahu ay u diro warbixinta la saxay qolayaha guryaha ee helay warbixinta khaladaadka lahayd 6dii bilood ee la soo dhaafay.
- **Hadii aadan ku raacasnayn** natijada baaritaanka la sameeyey, **waxa aad ku dari kartaa “oraahda mudaca”** warbixintaada. Hay'adu waxa ay ku koobi kartaa sharaxaadaada 100 eray. Oraahda, waxa aad ku oran kartaa sababta aad u diidan tahay xogaha warbixinta ku jira. Hay'adu waa khasab inay u dirto oraahdan qolyaha guryaha ee cusub. Hadii aad codsato, sidoo kale waa inay u diraan qolyaha guryaha ee heshay warbixintaada 6 dii bilood ee la soo dhaafay.

Maxaa sameeyaan kolka aad codsanayo guri?

- Runta sheeg. Hadii guri horey lagaaga saaeray ama xog xummi ku jirto diiwaankaaga, u sheeg qolada guriga. **Ka hor inta aadan bixin khidmada codsiga, waydii inay u badan tahay inaad guri heli doonto iyo in kale.**
- Isku day inaad ka hesho inay wanaag kaa sheegaan qolada guriga aad hada uga jirtaa. Hadii aysan taa yeelayn, ka hel warqad amaan ah qolada shaqadaada ama cid kale oo ku taqaan.
